

Custer County
Commissioner Meeting Proceedings
February 10, 2025

The meeting was called to order at 8:03 AM in the Custer County Commissioners Room by Chairman Randy Corgatelli with Commissioner Will Naillon, Commissioner Gordon Vaden, Clerk Lura Baker, Deputy Clerk Tamra Giampedraglia, Deputy Clerk Tina Hawkins, Road & Bridge Supt. Brandon Jones, Weed Supt. Brett Plummer and Karma Bragg in attendance.

Road & Bridge: Supervisor Brandon Jones advised that he received a call from the mail route driver for Morgan Creek late on Sunday, they are buried in snow again, Jones advised the caller that the decision to extend R&B services to plow that area is made by the County Commissioners and that it can only be done when R&B can get to it, not on request. Jones advised that per Schedule A, can go to the summit at any time, but going over the summit is on Forest Service permit. Per Commissioners, check with Forest Service and let them know and then will get to it when R&B are able to get equipment there.

Electrical for hydraulics in one truck has been down and is three weeks out on getting parts and getting it back on the road. Setting up an account with Certified Power Inc to be able to order parts directly in the future. Commissioner Naillon made the motion to accept the credit card charge of \$2419.74 for a flow control module to Certified Power Inc., Commissioner Vaden seconded and the motion passed. ABS sensor went down on truck that is normally run on Yankee Fork, having to use a blade on Yankee Fork at this time, may be out for a couple of weeks for repairs as well.

Looking into using radio frequency on Yankee Fork to be able to communicate with Hecla Mining Co in case of an emergency. Commissioner Naillon advised that this shouldn't be a problem, will look into this.

Jones advised that he is currently working on paperwork for the Protect Grant, this grant would be for funds to repair areas were there were fires. Will pay for the design work, with zero percent match, for culverts, guard rail etc. Yankee Fork culverts could be completed under this Protect Grant due to fire in that area. LTAC would actually be putting in for this grant on behalf of three separate counties, but R&B will have to sign agreement and write letter. Will need to have Commissioners agree to the grant pursuit. Commissioner Naillon made motion to sign PROTECT Grant approval if it comes available, Commissioner Vaden seconded and the motion passed.

In 2017 and 2018 there was an emergency ordinance for flooding on Morgan Creek, Kinnikinic Creek and Mill Creek. If we can prove that we were already permitted to do repairs on that flooding area and already did the work to repair, Custer County may be able to get reimbursed for that repair.

Jones gave update on the bridges planned for Squaw Creek, due to permitting there has been a design change which has put the projects out another year. Two of them to be done in 2026 and two in 2027, projects are still in designing stage for repair and replacement.

Jones advised that he will be putting a request for bids out to crush ½" chip, will be putting out notice but would like to have bid opening on March 26th during his reporting time. Commissioners agreed that this would be a good time to open bids for crushing.

Muleshoe Bridge below Clayton, put in for funding on this but LTAC stated that they would rather have it removed. Commissioner Naillon advised that he was not in favor of removal and believes that there needs to be more discussion regarding this bridge. Jones and Naillon went and looked at the bridge, Vaden would like to go up and look at the bridge. Commissioner Vaden and Jones will schedule a time to go up and review this bridge.

One Grader is up on lease and will be up next month, Jones has information on a lease for new grader. Total \$400,000.00 for a 5-year lease, will be replacing the grader that was \$273,000 on a 5-year lease. Going to a 4wheel drive rather than a tandem, which is more expensive but prices have gone up overall over past 5 years. Have an option to put a wing on this grader for an additional \$23,000, that can be put into the lease payment but R&B would own the wing attachment. Discussion regarding budgeting from last Fiscal Year and the upcoming Fiscal Year for this line item as funds will be tight. Commissioner Naillon asked if it would be better to wait a year to purchase the wing attachment outright rather than add it to the lease. Discussion regarding lease options and buy back stipulations in the leases that have been written up in the past. Commissioners asked Jones to see if there could be the option to lock in price on the wing attachment, but wait until October 1, 2025 to purchase the attachment outright at that time, Jones will look into it and come back at next Commissioner Meeting with information.

Weed Department: Weed Superintendent Brett Plummer updated the Commissioners on the Convention in Nampa he attended for Weed Control Superintendents Annual Meeting, tried to put him in as Vice President of the Superintendents Board, he declined as it conflicted with School Board Meetings. Next year they will move the meetings around and he will accept the position if offered. Received 11 continuing education credits for this conference, needs 16 every year to stay certified. Trying to add more species to the Noxious and Invasive Species list, but had discussion with legislature and committees to better define noxious and invasive species description, as some of these species they want to add would be very difficult to enforce. Discussion on the way different weeds are classified and how control is funded. Discussion also continued regarding check stations and funding for control of invasive water species as well.

Herbicide bids will go out Wednesday, February 12, 2025. Plummer does bids individually for herbicides to keep costs down. Commissioner Naillon asked about the agreement with the BLM, Plummer advised that there is still a fully-funded agreement with the BLM but do not have a participating agreement with the Forest Service. BLM does not have a weed crew for this year, Randall Anderson will be overseeing the weed program for the BLM. New spray truck with spraying equipment was partially funded by the BLM agreement, so County and BLM roads will be a priority.

Commissioner Corgatelli asked about summer personnel, Plummer advised that Ted Riley will be coming back temporary for the summer for 4 days per week. Plummer advised that Bonneville Co has several drone pilots and he is going to inquire about having one come up and contract some of the drone spraying work in Custer County to help there.

Steve Botti and the Sawtooth Coalition asked Plummer if he could come to Stanley and spray on SNRA and around Stanley. Plummer advised that they had needed to secure some of the funding to be able to contribute to paying for spraying. Blaine County Superintendent discussed this with Plummer and advised that they are now asking him to spray on the Custer side and he is going to decline. If they have funding and approval on SNRA, would possibly look into being able to go and do some work there, but otherwise there is not any way to be involved at this time.

Custer Soil & Water Conservation: Karma Bragg had wanted to bring Lori Ringle from RC&D, but Lori was unable to attend today and would like to come and meet at a later date. Bragg gave the Custer Soil & Water Cons Five-Year Resource Conservation Business Plan report, and the annual plan report. Wanted to make sure the Commissioners were aware that she is willing and available to help in any project that she can.

Ag Week the week of March 17 – 21, 2025. Will be a day at each of the schools and then end the week with a bag breakfast free to the public.

Kinnikinic culvert repair/replacement update, the cultural survey was declined by the private property owner, so they surveyed the lower culvert repair/replacement at the Clayton Silver Mine location. Will not be much of a cost for the County, mostly labor. Issues that they have been running into are the final inspectors are not agreeing with the amount of rock that is being put into the installation of these bridges, culverts. Would like to sit down with the inspector, surveyor, engineer and county entities to discuss the reasoning behind what they are wanting so that there won't be future problems with inspections. If could get this lower Kinnikinic culvert completed as soon as possible, before work on the Hwy 75 and above clayton silver mine culvert, would be less of a problem and be able to be completed sooner. Discussion on the process that the Custer Soil & Water goes through on a project and the benefits in planning and funding to the County to have that entity assist on these projects. Discussion regarding some of the larger projects that the Custer Soil & Water Conservation district has assisted with and completed in the County.

Treasurer: Allicyn Latimer gave her report on taxes collected, taxes remaining to collect and the amount of taxes cancelled by Commissioners per request of Assessor's office. Update on the Court Annex Building given by Latimer and Baker, the Supreme Court Trial Court Administrator, Tammy Whytte will be in Challis on February 18th at 8:00 am to do a walk through with the Commissioners of the Court Annex building.

Clerk: Lura Baker advised that there needed to be some discussion regarding the Stanley solid waste location, Troy Saffle from DEQ called Commissioner Naillon regarding the Stanley location, which needs to be described as a "non-municipal solid waste management disposal site" (or Convenience Drop Off Site) and also spoke with Clerk Baker, would like to have a conversation with the Commissioners regarding the specifics of this location. Discussion regarding the Mackay location as well, specifically the installation of a road and BLM permissions. Solid Waste charges were briefly discussed.

Commissioner Naillon made motion to go into Executive Session under I.C. 74-206(1)(f) for Legal, at 9:48 AM, Seconded by Commissioner Vaden, the roll call vote was unanimous Aye. Attending were Commissioner Corgatelli, Commissioner Naillon, Commissioner Vaden, Clerk Lura Baker, Deputy Clerk Tamra Giampedraglia, Deputy Clerk Tina Hawkins, Deputy Clerk Kristen Walker, Planning & Zoning Administrator Jessica Clemenhausen and Land Use Attorney Zack Jones via Zoom. No decisions were made during this session and the board returned to regular session at 10:50 AM.

Commissioner Naillon made motion to approve the meeting minutes from the January 24, 2025 meeting, Commissioner Vaden seconded and the motion passed.

Commissioner Corgatelli made motion to approve meeting minutes from the G2G (Government to Government) meeting from September 30, 2024, seconded by Commissioner Vaden, motion passed.

The meeting was recessed at 10:57 AM to go into South Custer Ambulance District. Commissioner Naillon made motion to approve the meeting minutes of January 24, 2025, Commissioner Vaden seconded and motion passed. Commissioner Naillon made motion to approve claims in amount of \$5665.69, motion seconded by Commissioner Vaden, motion passed unanimously. Discussed that South Custer will come before them at next meeting in regards to third party billing. The regular meeting was reconvened at 10:59 AM.

NRAC: Jim Hawkins passed out an email handout from a Crystal Johnston in regards to a meeting with the County Commissioners. However, he feels that a joint and formal G2G meeting would be better than just an informal meeting with the local Forest Service Office. Commissioners agreed that they would rather have a more in-depth meeting regarding the Forest Service Plan. It was agreed that an informal meeting would be declined and a G2G meeting attended.

Update on Custer Motorway improvement, the Forest Service would like to have it shut down for four (4) months in order to improve and repair the Custer Motorway road. His concern is the affect of the shutdown on the local community and the established mines in that area. Commissioner Naillon advised that he felt that there needs to be some clarification on where these locations of shutdown will be, the length of time of the shutdown and their plan for those that would need to access that area. Commissioners will discuss this with the Forest Service representative.

Discussion regarding Mary Darling, BLM and comments made regarding the Sage Grouse, he advised that he feels that they have failed to address the concerns made by Custer County and there are issues they need to address in the Public Use Policy, economic impact of changes to local community, feels Commissioners need to ask Mary Darling to address these issues and submit comments. Commissioner Corgatelli advised that he would like to have Mary Darling address these issues and submit comment. Deputy Clerk Hawkins made note to communicate to Mary Darling regarding this and any other issues that may be addressed.

David Philps will be going back to Washington DC as a representative of the Idaho Farm Bureau and he would like to take back information regarding the most recent Wildland Fires. He would like to have information regarding the cost of the fires, specifically he Wapiti Fire. Commissioner Naillon advised that as there were approximately a million acres of forest that burned in Idaho last season, they should have an estimated cost and that could be asked and given to Philps for his information.

Clerk: Clerk Baker gave the Commissioners a copy of the Custer County Audit that was completed by Gary Merkle. The Commissioners reviewed the documents and Commissioner Naillon made motion to approve Audited Financial Statements Report, seconded by Commissioner Vaden, motion approved unanimously.

The North Custer Rodeo has requested financial information and a letter of support from the Commissioners for a grant that they are putting in for

10th Annual Local Project Awareness and Utility Coordination Meeting on February 25, 2025 at 1:30 PM, Deputy Clerk Hawkins will attend, take notes and bring back information to the Commissioners.

Clerk Baker advised that Jolie Turek from Economic Development brought to her attention that the Department of Commerce needed an approval signed for an amendment to the fiscal year 2025 grant funding. Commissioner Naillon made motion to approved the Rural Idaho Professional Development grant amendment, along with the invoice of \$5000 to Custer County Economic Development, motion seconded by Commissioner Vaden, motion passed. Commissioner Naillon made motion that upon acquisition of these funds in the amount of \$5000, this extra funding will be paid directly to CEDA, motion seconded by Commissioner Vaden, motion passed.

A Certificate of Residency was brought before the Commissioners. Commissioner Naillon made motion to approve Certificate of Residency for T. Baker, motion seconded by Commissioner Vaden, motion approved unanimously.

The Board for the Eastern Idaho State Fair has requested an annual contribution from Custer County. Motion was made by Commissioner Vaden to approve a \$1500 contribution for the Eastern Idaho State Fair, motion seconded by Commissioner Corgatelli, motion passed.

Clerk Baker advised that Keller & Associates with LTAC are designing a sidewalk along 9th street. These proposed improvements will run along 9th street, along the Custer County Courthouse. This information was presented to Commissioners for review, they did not object to these improvements but wanted to look it over.

Janitorial services for the Custer County Courthouse was presented for Commissioner review due to an increase. Per Commissioners, the janitorial services will be put out for bid due to the amount of increase. Will notify KY Real Estate Services that their increase is over 10% and the service will be submitted for bid.

Clerk Baker discussed the option of possibly closing the court staff department for Clerk Filings, as there needs to be time for the Court Clerks to be able to update court filings and proceedings. The increase in court filings has made it difficult for staff to stay caught up with data input. The proposed new schedule would be Monday 8:00 AM to 4:00 PM and Tuesday through Friday 9:00 AM to 4:00 PM. Commissioner Naillon made motion to approve the Court Clerk Filing times, motion seconded by Vaden, motion passed. Will post new clerk filing schedule.

The meeting was recessed for lunch at 12:01 PM and reconvened again at 1:31 PM. Commissioner Corgatelli, Commissioner Naillon, Commissioner Vaden, Deputy Clerk Giampedraglia and Deputy Clerk Hawkins in attendance.

Federal Agencies:

Chris Waverick (USFS – Salmon/Challis) – Reported that they are in a hiring freeze at this time like most of the Nation, half of the office is on probation (1st and some 2nd year employees) from Federal Gov. Had to rescind a few employment offers that were sent out until after the Federal Government decides on what will happen with Presidents orders. Group has reached out to the USFS concerning a mid-July atv/utv ride over the Custer Motorway. MP 24 and 25.3 (couple miles) on Custer Motorway between May and August 2026 will be completely closed, completely ripping the road out and putting down a base as there is stability issues and rerouting the stream in that area, will be working with grazing permittees during that period of closure. After road is replaced, the County will then take over management of the entire Custer Motorway. If there are any questions regarding this, he is asking that

those be brought to him as soon as possible so that they can start thinking of those things. Working with local trails collaborative on a cross country ski trail. Starting to see a little use conflict between snow bikes and skiers up Cape Horn area. G2G meeting on the 18th at the USFS meeting room for Forest Plan Revision, Commissioners would like to have another meeting with Lemhi County and the USFS regarding Colson Creek and other areas that affect both Counties. Currently have some vacancies for their RAC committees.

Lance Stavast (Lost River Ranger Dist.) will be using a grant in from IDPR for the Borah campground improvement, had some fire employees that were supposed to start today so that they could have an engine crew on the Mackay side but now due to the hiring freeze they have been cancelled. The snow levels are looking good in the Mackay area.

Mike Fuller (Sawtooth National Forest) Fixed the Valley Creek Bridge, now working on the Elk Creek Bridge. Had approximately 200 snowmobilers in the Stanley area last weekend. Put in for 1.8 mile of fencing that was affected by the Wapiti Fire to replace. Trying to finish up on the burning of slash piles. Sent 20 firemen to California to assist with the fires recently. One positive thing for Stanley area is the kids got to move into their new classrooms in the new remodel project at the school in Stanley. Commissioner Naillon asked if the USFS could get the total cost of the Wapiti fire, Fuller advised that he would look into it.

Dave Hilliard (BLM) Will have temporary closure on Mahogany creek in Pahsimeroi at the crossing for about a mile of upgrading and culvert at the creek, will be closed for just a couple of weeks. The Challis Bridge site will have a temporary closure, at the day use area road and parking lot for repairs, and the Bayhorse recreation site will have a temporary closure to repair the road and irrigation but will try to keep as much of the campground open as they can while they replace the irrigation system. Those closures will be Summer 2025. Commissioner Naillon asked about the extension of the Joe Fallini Campground at Mackay Reservoir, Hilliard advised that the third loop design is in the works right now and should add about 12 new sites and another pavilion and amphitheater with walking path, conceptual designs to be complete in next few weeks, actual completion within next few years.

Mary D'Aversa (BLM Idaho Falls District) Advised that they are currently between field managers, were set to hire a permanent field manager that has been put on hold during this hiring freeze, this person has a strong background in range, fuels and fire and should be a good fit for this area and hope to still be able to have this person fill this position within a month. Dave Hilliard will be the temporary manager in the interim. Wildland fire and other public safety positions are going to be released from the hiring freeze sooner than other positions as it is more of an emergency position. They don't have an engine in the Challis area however, due to their agreements with the USFS. In 2024, the Challis office ran at about 50% staffing, need 24 employees to be at full staff normally.

Wanted to ask the Commissioners who the BLM contact would be of the three Commissioners, Commissioner Will Naillon volunteered for this position.

Department recently approved a resource advisory committee (RAC) for the State, have always wanted someone from each district to be on this committee, Leon Smith had been on the RAC but currently is not active and there is not another committee applicant for Custer County. She will make sure that the Commissioners are aware and get the information out so that the Commissioners can make the

Information available. There are three types/groups of RAC committees and the vacancies come up typically once a year, usually up to an 11-member board.

Submitted a grant application to State Parks for the mountain bike trail adjacent to the City, for a skills course for mountain biking. Hoping to secure these funds and help the City with this project.

Asked the Commissioners if they had seen anything come through for high-water water rights in Custer County, as they have been seeing some of this come through Lemhi County, approximately 30 applications have come through. Commissioners advised that most rights have been adjudicated and haven't seen anything like this come up.

G2G follow up, the monitoring of Juniper treatment has been completed. The Commissioners asked for a status on the new BLM Building, Mary advised that BLM legal-council, Ann Briggs has been in contact with Prosecutor Justin Oleson, and advised him that BLM is not subject to County P&Z ordinances and that is basically where that was left. It has come to the parties basically legally agreeing to disagree, P&Z Clemenhagen confirmed that notion. Commissioner Naillon asked about the other logistics for this building plan, D'Aversa advised that due to funding, building their own building came down to the most cost-effective option and that is why they have decided they needed to build their building at the Challis Bridge site, the Valley Rd site became too expensive due to having to move a powerline. Regardless of where they put the building, they are committed to being "good neighbors". Commissioner Naillon asked if there would be a public meeting regarding this building, discussion ensued regarding how the public were notified and the support or lack of. They are open to having a public meeting and speaking about the building, and how to make this space the most palatable rather than the option that the building be built in another location. Commissioner Vaden asked why they would be averse to going through the County P&Z process, this would have a built-in hearing within the process. D'Aversa advised that it is felt that it would be a waste of P&Z time. Commissioner Naillon allowed Jim Hawkins to speak regarding some of the concerns the citizens had, regarding sewer and temporary housing. D'Aversa advised that they will follow and meet all State laws and they are prepared to do so in a positive manner, she also advised that the plan for temporary housing has been cancelled at this point due to funding.

Wild horse update on the horses creating a highway hazard, they have tentatively scheduled a round up this fall. Will try and remove some horses to help with the overpopulation. Want to foster a conversation between ITD, Thompson Creek Mine and the BLM themselves to try and help find a solution. Giampedraglia advised that the horses are coming down for water and that the gates are not in very good condition, replacing the gates may assist in the public actually shutting them when they go through and keeping the horses above portions of the drift fence. Horses are still coming down onto the highway, mostly at dark.

Custer County Sheriff: Sheriff Maydole gave his Department Status Report to Commissioners for review. Commissioners reviewed the report and asked questions regarding inmates, equipment and staffing. Sheriff Maydole advised that he feels that the Chief Deputy needs to be a salaried position, as they accumulate so much overtime and comp time. Would also like to add another position to his staffing, as a Chief Administration Officer, as he feels he needs to have help with paperwork. This is not a post certified position but would alleviate his need to have to stay behind the desk and be able to be out assisting officers. He advised that he has it in his budget if he does not have a new detention officer, as he has not been able to get a detention officer to apply. Commissioner Naillon asked how this

position would fit in if there were to be a new jail completed and new detention officers would be hired, wouldn't this take one position away in the future. Maydole advised that there needs to be more discussion regarding the jail and the logistics of operating the jail if one were to be built.

Commissioners agreed that there needs to be a discussion scheduled to go over the proposed jail and staffing, tentative two-hour block at next Commissioners meeting.

Maydole addressed the status of Reserve Sheriff Deputies, IDAPA no longer recognizes the "reserve" deputy status and would like to have his current Reserves be corrected to a Part-Time Deputy status rather than reserve.

Maydole gave the Commissioners the Law Enforcement Mutual Assistance Contract between Custer and Lemhi Counties for assistance with K9 handling support. Commissioners agreed to have Prosecutor Oleson review the MOU and will discuss at the next meeting.

Emergency Management: Lisa Benson gave an IEMA Conference report, spoke with some beneficial vendors such as the CRG Critical Response Group for mapping schools and large buildings, Idaho Geological Surveying for mapping on earthquake fault lines, landslides, mining and more (could do a presentation for the Commissioners, which the Commissioners were receptive to)

Region 6 update report was given to the Commissioners for review. Also gave Commissioners an example of Jefferson County's Senior Officials Guide and the Custer County Emergency Operations Plan for review, will have Prosecutor Oleson review both documents.

Grants are currently on hold through Federal Government at this time, will not start any new grant applications at this time. ISP may have some grants available, Benson will look into these.

Mackay Reservoir Dam meeting was held and there were not any participants from Lost River Irrigation District. Was a very short meeting as there is not much in the works at this time.

Planning & Zoning: Jessica Clemenhagen advised that the P&Z Board is not going to pursue adding additional seats to the P&Z Board at this time, as it is hard to get a quorum as it is. Clemenhagen advised that Chairman Tritthart has requested that the workshops start for reviewing and revising the Custer County Comprehensive Plan. Clemenhagen would also like to have a working lunch with P&Z Board and Commissioners, looking at around March 12-13. Commissioners agreed to allow Clemenhagen to discuss some current building issues with the Land Use Attorney. Seth Grigg from IAC has advised that he would come up and do a training for the Commissioners and the P&Z Board at the end of April, Commissioner Vaden will follow-up with Grigg to set a time.

FireWise: Tucker Flaten sent new agreement for the FireWise program/plan, Commissioners will need to review this information and decide on this agreement and also discuss location for the FireWise Community Program utilization. Flatten attended the meeting via Zoom and gave the Commissioners a brief introduction and history of the work completed for Custer County. Gave list of services that are available to Custer County. Met with the newly formed Sawtooth Valley Wildland Fire Collaborative last week. Gave some examples of benefits of work that was completed at the Homestead Subdivision in Stanley and could have been a benefit in the Iron Creek and Crooked Creek Subdivisions. Commissioner Naillon wanted to clarify that some work during suppression efforts was actually accomplished by the USFS, Flaten did advise that some of the work he had slated has been completed. Commissioner Naillon advised that he would like to also look at other locations that could utilize this

type of work to help prevent fire. Flaten agreed that he would be open to being given direction on locations to triage. Commissioners reviewed several locations that they felt could benefit from this type of services. Clerk Baker gave a history of some work that was completed in the Mackay area. Flaten advised that each project has to meet three criteria to be considered, it has to decrease expected fire activity, increase firefighter safety, firefighter access and also ability to leave the material/residuals once it has been processed to reduce fuels for fire. Flaten advised that the current CWPP should have a definition for Custer County on the areas that would qualify. Crooked Creek and Iron Creek still needs to be re-assessed due to the Wapiti Fire, but not under any obligation to continue doing the work there in that area. Flaten would like to have a unified front on the decision to continue or not to continue, after the re-assessment. Would also encourage the use of local contractors to complete the treatment.

Will be coordinating with the other land management agencies that will be doing fire rehab from the Wapiti Fire. Clerk Baker advised that the Commissioners will be attending a Zoom meeting on February 26th with those entities. Flaten feels that the community needs to be educated in the fact that these grant funds are for treating fuels and reducing fuels, not on retrofitting building materials for dwellings. Commissioners agreed that this is not what the money is available for, not for improving the structures, it's for the reduction of fuels to reduce fire activity.

Clerk Baker advised that there is a Letter of Engagement that would need to be reviewed and signed if Commissioners so wish. Commissioner Naillon made motion to sign the Letter of Engagement for professional services from Northwest Management, Seconded by Commissioner Vaden and motion passed unanimously. Letter will be signed and returned to Tucker Flaten.

Flatten advised that he would like to include neighboring Counties for bidding in "local" contracting for bids. Commissioners agreed that bidding could be extended to neighboring areas to assist in a more competitive price.

Claims: Commissioner Naillon had some questions regarding some of the claims that were submitted. 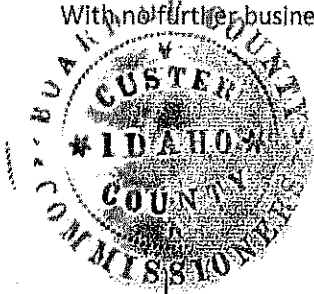

Truck. She will go to Salmon River Motors on Wednesday and look at the vehicles and take the Ford truck, if she has questions she will contact the Commissioners.


