F. Water situation, bathrooms and cook shack??? – Jake recommended calling Wrangler Williams from Mackay. He is a licensed electrician and has helped at the fairgrounds a lot. Mark and Kurtis will go to the rodeo grounds and survey the situation to know what we will need to do. It was mentioned that Bill Bradshaw was supposed to drain everything, and we haven't heard whether it got done or not. Terri is wondering why this isn't a scheduled event with someone who does winterizing so that it is just completed every year like the sprinklers are blown out on a yearly scheduled basis.

G. Other Business

- a. Kurtis suggested installing frost free hydrants so that water is available on the ground's year around. We had wild horse gatherers who wanted to stay and keep horses there, but we had no water available this winter.
- b. We need to order pipe to finish the back holding pens
- c. Locking up the grounds with a combination lock that will be changed each year, and paid members will be given the combo each year that they pay. This would cut down on the amount of trash put into our dumpster and help to get us paid for grounds usage as well.
- d. Put in water lines with a drip system, plant trees for campers
- e. Mark suggested having power ran down the north side of the grounds for hookups for campers, trailers, etc.
- f. Purchase water truck so the grounds can be watered without asking someone to do it for us. Everyone will watch for water trucks for sale.
- g. Kurtis talked about the roping club at the rodeo grounds
- h. Jake suggested the rodeo grounds look for someone to stay and keep an eye on the grounds, collect fees and help keep things in order. He talked
