- C. Grounds Clean up
 - a. Weed spraying – Brett is on it, will sterilize the horse stalls, drive ways, and arena area – must be free of stock for 48 hours after spraying
 - i. Contact Brett for a heads up a couple weeks before he wants to spray - Change the code for that weekend so nobody uses the arena – Tell Mike, Kip, Jerry about spraying so they can move stock for the weekend
- D. Plumbing repair update, see invoice
 - a. Leak under the big sink in the kitchen, must be fixed as well as the main valve in the mechanical room –
 - i. Bill told Adrienne about all this and that we need a pressure system set up on the well on the grounds, she will look at it and figure out a system
