

Custer County Commissioner
Board of Equalization
March 11, 2024

The meeting was called to order at 10:48 AM by Commissioner Chairman Randy Corgatelli. Also present were Commissioner Steve Smith, Commissioner Jake Zollinger, Clerk Lura Baker, Deputy Clerk Tamra Giampedraglia and Assessor Jacquiel Bruno. The following applicants were reviewed:

Challis Masonic Lodge #92 – 1 parcel under #63-602C. The application is on the new short form, properly filled out and financials look in order and up to date. Assessor Bruno advised that all information appeared to be complete. Commissioner Smith moved to approve the exemption, Commissioner Zollinger seconded and the motion passed unanimously.

Mackay Senior Citizens – 1 parcel under #63-602C. The new short form application is complete with all questions being answered. The financials look to be in order. Assessor Bruno advised that she had reviewed the information and it looked to be in order. Commissioner Smith made a motion that the exemption be accepted. Commissioner Zollinger seconded and the motion passed unanimously.

Mount McCaleb Masonic Lodge #64 – 2 parcels under #63-602C. The new short form application is complete, with all necessary financial information. Commissioner Zollinger moved to approve the exemption for Mt. McCaleb Lodge #64. Commissioner Corgatelli seconded the motion, and it passed with a roll call vote of Commissioner Zollinger and Commissioner Corgatelli. Commissioner Smith abstained from the vote due to a conflict.

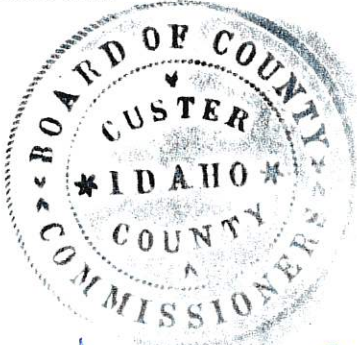
Heart of Idaho Animal Sanctuary – 1 parcel under #63-602C. The new short form application is complete and the financials were included. There was discussion regarding this entity and the service they provide to the community. Assessor Bruno reviewed the financials submitted and advised that everything seemed to be in order. Commissioner Smith made motion to approve the exemption, Commissioner Zollinger seconded the motion and the motion passed unanimously.

Roman Catholic Diocese of Boise – 2 parcels under #63-602B. The parcels are in Mackay and Challis. The short form application is completed and the financial information has been included. Commissioner Smith moved that the exemptions be approved for St. Barbara's and St. Louise Catholic churches. Commissioner Zollinger seconded the motion and it passed unanimously.

Clayton Historical Association – 1 parcel under #63-602C. The new short form application is complete and the financials were included. Assessor Bruno advised that after review, all

information is in order. Commissioner Smith moved that the exemption be accepted.
Commissioner Zollinger seconded the motion and the motion passed unanimously.
